**[Prevention]**

Do not get in eyes, on skin, or on clothing. Use only outdoors or in a well-ventilated area. Do not eat, drink or smoke when using this product. Wash hands and face thoroughly after handling. Wear respiratory protection. Wear protective gloves, protective clothing, face protection.

**[Response]**

If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower.
