Keep away from flames and hot surfaces. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing. A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.

<b>Storage conditions:</b>	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store away from incompatible materials such as oxidizing agents. Light-sensitive
