**[Prevention]**

Keep away from flames and hot surfaces. – No smoking. Keep only in original container. Do not breathe dusts or mists. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.

**[Response]**

If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. <b>Storage conditions:</b>	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store locked up. Store away from incompatible materials such as oxidizing agents.
