4. FIRST AID MEASURES

First aid measures

General Advice:

Skin Contact:

Wash off immediately with soap and plenty of water. Continue flushing with plenty of water for at least 15 minutes. Remove all contaminated clothes and shoes. Immediate medical attention is required. Call a physician or Poison Control Centre immediately.

Eye Contact:

Flush eye with water for 15 minutes. Immediate medical attention is required. Call a physician immediately.

Inhalation:

Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. **WARNING!** It may be hazardous to the person providing aid to give mouth-to-mouth resuscitation when the inhaled or ingested material is toxic, infectious or corrosive. 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Personal Precautions: Ensure adequate ventilation. Use personal protective equipment. Avoid contact with skin, eyes and clothing. Avoid dust formation. Keep people away from and upwind of spill/leak. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Remove all sources of ignition.

Methods for containment Stop leak if you can do it without risk. Absorb spill with inert material (e.g. vermiculite, dry sand or earth). Cover with plastic sheet to prevent spreading.

Methods for cleaning up Sweep up and shovel into suitable containers for disposal. Clean contaminated surface thoroughly.
