#### **Description of first aid measures**

##### **General advice**

Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.

##### **Inhalation**

Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. If breathing is difficult, (trained personnel

May cause sensitization in susceptible persons. Treat symptomatically.
