Description of first aid measures

General advice

Inhalation

Remove to fresh air.

Eye contact

Skin contact

5. Fire-fighting measures

Personal precautions Ensure adequate ventilation. Avoid contact with skin, eyes or clothing. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Cover with DRY earth, DRY sand or other non-combustible material followed with plastic sheet to minimize spreading or contact with rain.

Methods for cleaning up With clean shovel place material into clean, dry container and cover loosely; move containers from spill area. Flush area with flooding quantities of water. Prevent product from entering drains. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry.
