## 4. First-aid measures

### Description of first aid measures

<b>General advice</b>	Show this safety data sheet to the doctor in attendance. Immediate medical attention is required. IF exposed or concerned: Get medical advice/attention.
<b>Inhalation</b>	Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. If breathing is difficult, (trained personnel should) give oxygen. Delayed pulmonary edema may occur. Get immediate medical advice/attention.

**Symptoms** Burning sensation.

### Indication of any immediate medical attention and special treatment needed

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure.

## 5. Fire-fighting measures

<b>Suitable Extinguishing Media</b>	Use water. Do not use dry chemicals or foams. CO <sub>2</sub> or Halon may provide limited control. Flood fire area with water from a distance. Move containers from fire area if you can do it without risk. Cool containers with flooding quantities of water until well after fire is out. CAUTION: Use of water spray when fighting fire may be inefficient.

<b>Unsuitable extinguishing media</b>	Dry chemical. Foam.
<b>Specific hazards arising from the chemical</b>	These substances will accelerate burning when involved in a fire. Some may decompose explosively when heated or involved in a fire. **Personal precautions**    Ensure adequate ventilation. Avoid contact with skin, eyes or clothing. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. ### **Methods and material for containment and cleaning up**

**Methods for containment**    Dike far ahead of spill; use dry sand to contain the flow of material. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers. Stop leak if you can do it without risk.

**Methods for cleaning up**    Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. With clean shovel place material into clean, dry container and cover loosely; move containers from spill area. Flush area with flooding quantities of water. Prevent product from entering drains.

## **7. Handling and storage**

### **Precautions for safe handling**

**Advice on safe handling**    Use personal protection equipment. Avoid contact with skin, eyes or clothing. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources.
