6. ACCIDENTAL RELEASE MEASURES

Methods for cleaning up Absorb spill with inert material (e.g. vermiculite, dry sand or earth), then place in a suitable chemical waste container. Neutralize with Sodium carbonate or Sodium bicarbonate. Clean contaminated surface thoroughly.
