**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions, protective equipment and emergency procedures:** Use extra personal protective equipment (self-contained breathing apparatus). Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.

**Environmental precautions:** Prevent product from entering drains.

**Methods and materials for containment and cleaning up:** Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

**Prevention of secondary hazards:** Do not allow contact with water. Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment. Since there is a possibility of igniting behind when removal of a leakage thing is imperfect, it is careful enough.

<b>Precautions for safe handling:</b>	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing. Confirm in advance if peroxides exist when operations involving heating such as distillation are carried out. Keep away from any possible contact with water, because of violent reaction and possible flash fire. Use well-dried equipment. Handle under inert gas. Don't leave used equipment or rag. This product may ignite if it is left stuck on combustibles such as paper, rags, etc.
