4. FIRST AID MEASURES**First aid measures**

5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media: Dry chemical. Carbon dioxide (CO₂). Water spray mist or foam.

Unsuitable Extinguishing Media: Do not use a solid (straight) water stream as it may scatter and spread fire.

Specific hazards arising from the chemical

Hazardous combustion products Carbon monoxide. Carbon dioxide (CO₂). hydrogen chloride gas.

Specific hazards Combustible material. Vapors may form explosive mixtures with air. Most vapors are heavier than air. They will spread along the ground and collect in low or confined areas (sewers, basements, tanks). Container explosion may occur under fire conditions or when heated. When heated to decomposition it emits acrid smoke and irritating fumes. May be ignited by heat, sparks or flames.

Special Protective Actions for Firefighters

Specific Methods: Water mist may be used to cool closed containers For larger fires, use water spray or fog. Cool containers with flooding quantities of water until well after fire is out

Special Protective Equipment for Firefighters: As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Personal Precautions: Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Avoid contact with skin, eyes and clothing. Use personal protective equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Use spark-proof tools and explosion-proof equipment. All equipment used when handling the product must be grounded. Remove all sources of ignition.

Environmental precautions Prevent further leakage or spillage if safe to do so. Do not let product enter drains. Prevent entry into waterways, sewers, basements or confined areas.

Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Absorb spill with inert material (e.g. vermiculite, dry sand or earth), then place in a suitable chemical waste container. In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Use clean non-sparking tools to collect absorbed material. Clean contaminated surface thoroughly.

7. HANDLING AND STORAGE

Precautions for safe handling

Technical Measures/Precautions:

Provide sufficient air exchange and/or exhaust in work rooms. Remove all sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials.

Safe Handling Advice:

Wear personal protective equipment. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Do not ingest. Do not breathe vapors or spray mist. Handle in accordance with good industrial hygiene and safety practice.
