5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Dry chemical, foam, water spray, carbon dioxide.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Precautions for safe handling: Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent dispersion of dust. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a local exhaust if dust or aerosol will be generated. Avoid contact with skin, eyes and clothing.
