5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Use extra personal protective equipment (self-contained breathing apparatus). Keep people away from and upwind of spill/leak.
