Use explosion-proof equipment. Avoid shock and friction. Wash hands and face before breaks and immediately after handling the product. Use a local exhaust if dust or aerosol will be generated. Avoid contact with skin, eyes and clothing. Don't leave used equipment or rag. This product may ignite if it is left stuck on combustibles such as paper, rags, etc.
