**6. ACCIDENTAL RELEASE MEASURES**

**Precautions for safe handling:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Wash hands and face thoroughly after handling. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing. Confirm in advance if peroxides exist when operations involving heating such as distillation are carried out.
