**Precautionary Statement(s):**  
[Prevention]

Keep away from heat, sparks, open flames and hot surfaces. – No smoking. Keep container tightly closed. Keep only in original container. Ground and bond container and receiving equipment. Use explosion-proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe dusts or mists. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.

[Response]

If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. Immediately call a poison center or doctor. Wash contaminated clothing before reuse. If inhaled: Remove person to fresh air and keep comfortable for breathing. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

May develop pressure. Open carefully. Use corrosive resistant equipment.

<b>Storage conditions:</b>	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store under inert gas. Protect from moisture. Store locked up. Store away from incompatible materials such as oxidizing agents. Moisture-sensitive
