**[Prevention]**

Use only outdoors or in a well-ventilated area. Do not eat, drink or smoke when using this product. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.

**[Response]**

**5. FIRE-FIGHTING MEASURES**
