6. ACCIDENTAL RELEASE MEASURES

Environmental precautions: Methods and materials for containment

Methods and materials for containment and cleaning up: Be careful not to let it flow into rivers, etc., since adverse effects on the environment are concerned. Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Prevention of secondary hazards:

Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.
