6. ACCIDENTAL RELEASE MEASURES

Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Cover with plastic sheet to prevent spreading.

Methods for cleaning up Sweep up and shovel into suitable containers for disposal. Clean contaminated surface thoroughly.
