### 4. FIRST AID MEASURES

#### First aid measures

##### **General Advice:**

Poison information centers in each State capital city can provide additional assistance for scheduled poisons (13 1126)

##### **Skin Contact:**

Wash off immediately with soap and plenty of water. Continue flushing with plenty of water for at least 15 minutes. Remove all contaminated clothes and shoes. Immediate medical attention is required. Call a physician or Poison Control Centre immediately.

##### **Eye Contact:**

Flush eye with water for 15 minutes. Get medical attention.

##### **Inhalation:**

#### **Extinguishing Media**

##### **Suitable Extinguishing Media:**

Carbon dioxide (CO<sub>2</sub>). Dry chemical. Water spray. Alcohol-resistant foam.

##### **Unsuitable Extinguishing Media:**

**6. ACCIDENTAL RELEASE MEASURES****Personal precautions, protective equipment and emergency procedures****Personal Precautions:**

Ensure adequate ventilation. Keep people away from and upwind of spill/leak. Avoid contact with skin, eyes and clothing. Use personal protective equipment. Remove all sources of ignition. Pay attention to flashback. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Use spark-proof tools and explosion-proof equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. In case of large spill, water spray or vapor suppressing foam may be used to reduce vapors, but may not prevent ignition in closed spaces.

**Environmental precautions**

Prevent further leakage or spillage if safe to do so. Prevent product from entering drains. Prevent entry into waterways, sewers, basements or confined areas.

**Methods and material for containment and cleaning up****Methods for containment**

Stop leak if you can do it without risk. Absorb spill with inert material (e.g. vermiculite, dry sand or earth). In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

**Methods for cleaning up**

Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Use only non-sparking tools. Clean contaminated surface thoroughly.

**7. HANDLING AND STORAGE****Precautions for safe handling****Technical Measures/Precautions:**

Provide sufficient air exchange and/or exhaust in work rooms. Remove all sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials.

**Safe Handling Advice:**

Wear personal protective equipment. Use only in well-ventilated areas. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Do not breathe vapors or spray mist. Do not ingest. When using do not smoke. Handle in accordance with good industrial hygiene and safety practice.
