4. FIRST AID MEASURES

First aid measures

5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media:

Carbon dioxide (CO₂). Dry chemical. Water spray. Alcohol-resistant foam.

Unsuitable Extinguishing Media:

Do not use a solid (straight) water stream as it may scatter and spread fire.

Flammable
May be ignited by heat, sparks or flames

Most vapors are heavier than air. They will spread along the ground and collect in low or confined areas (sewers, basements, tanks)

Special Protective Actions for Firefighters

Specific Methods:

Water mist may be used to cool closed containers. For larger fires, use water spray or fog. Cool containers with flooding quantities of water until well after fire is out. Dike fire-control water for later disposal; do not scatter the material.

Special Protective Equipment for Firefighters:

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Personal Precautions:

Ensure adequate ventilation. Keep people away from and upwind of spill/leak. Avoid contact with skin, eyes and clothing. Use personal protective equipment. Remove all sources of ignition. Pay attention to flashback. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Use spark-proof tools and explosion-proof equipment. In case of large spill, water spray or vapor suppressing foam may be used to reduce vapors, but may not prevent ignition in closed spaces.

Environmental precautions

Prevent further leakage or spillage if safe to do so. Environmental hazard. Prevent product from entering drains. Prevent entry into waterways, sewers, basements or confined areas.

Methods and material for containment and cleaning up

Methods for containment

Stop leak if you can do it without risk. Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up

Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Use only non-sparking tools. Clean contaminated surface thoroughly.

7. HANDLING AND STORAGE

Precautions for safe handling**Technical Measures/Precautions:**

Provide sufficient air exchange and/or exhaust in work rooms. Remove all sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials.

Safe Handling Advice:

Wear personal protective equipment. Use only in well-ventilated areas. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Do not breathe vapors or spray mist. Do not ingest. When using do not smoke. Handle in accordance with good industrial hygiene and safety practice.

Keep container tightly closed in a dry and well-ventilated place. Store at room temperature in the original container. Store away from incompatible materials. Store in a segregated and approved area.
