In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Prevention of secondary hazards: Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use

spark-proof tools and explosion-proof equipment.
