#### 5. FIRE-FIGHTING MEASURES

#### 6. ACCIDENTAL RELEASE MEASURES

#### 7. HANDLING AND STORAGE

**Precautions for safe handling:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid all contact! Confirm in advance if peroxides exist when operations involving heating such as distillation are carried out.

**Storage conditions:** Keep container tightly closed. Store in a cool and dark place. Store under inert gas. Protect from moisture. Store locked up. Store away from incompatible materials such as oxidizing agents. Hygroscopic Air-sensitive
