6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment

and cleaning up:

Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Prevention of secondary hazards: Do not allow contact with water. Remove all sources of ignition. Fire-extinguishing devices should be

prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.
