6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment

and cleaning up:

Prevent product from entering drains. Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be

7. HANDLING AND STORAGE

generation of vapour or mist. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands
