6. ACCIDENTAL RELEASE MEASURES

Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
Environmental precautions:	Prevent product from entering drains.
Methods and materials for containment and cleaning up:	Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing.
