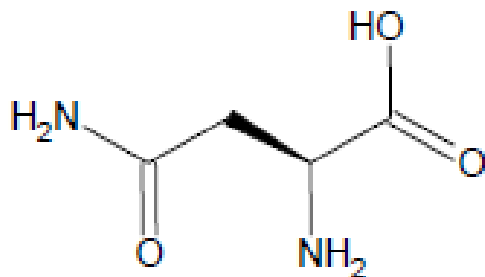

Manufacturing Process Flowchart L-Asparagine, Monohydrate, FCC (Cat# A1373)

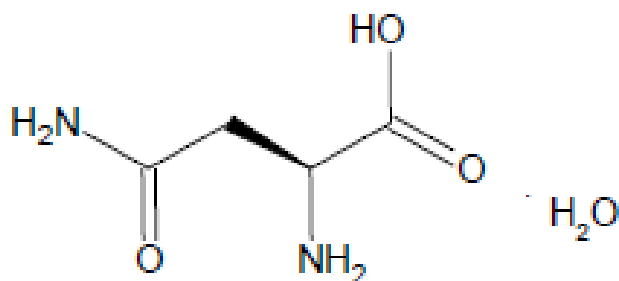


1) H₂O / NaHCO₃
