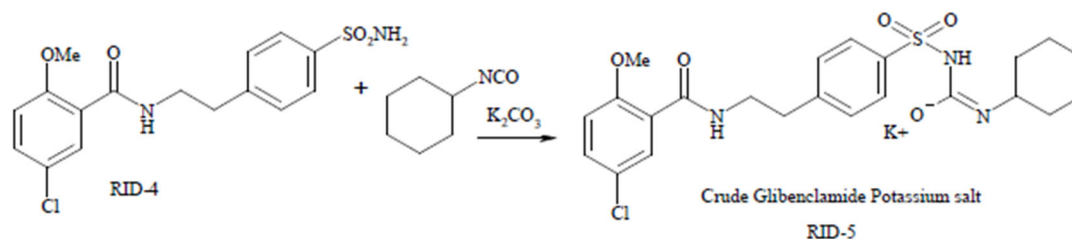

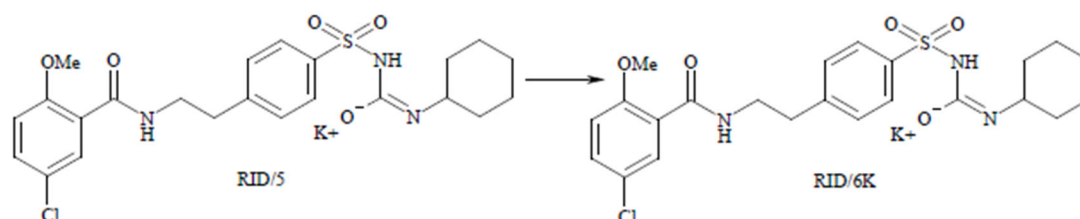

Manufacturing Process Flowchart Glyburide, USP (Cat# G1130)

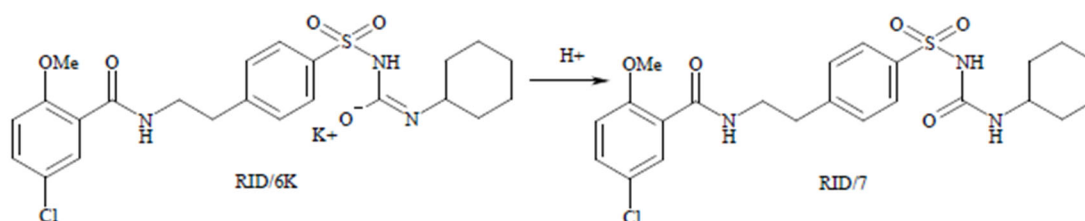
Step. 1: preparation of RID/5



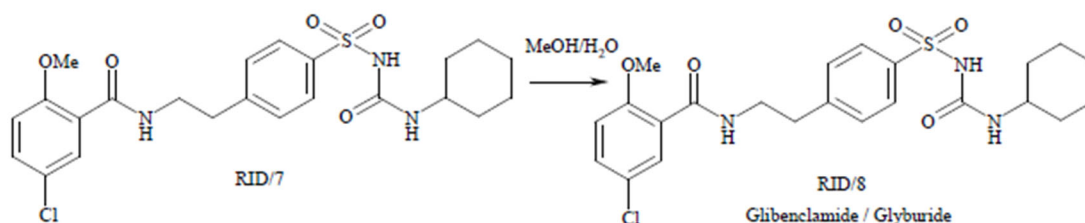
Step. 2: preparation of RID/6K
