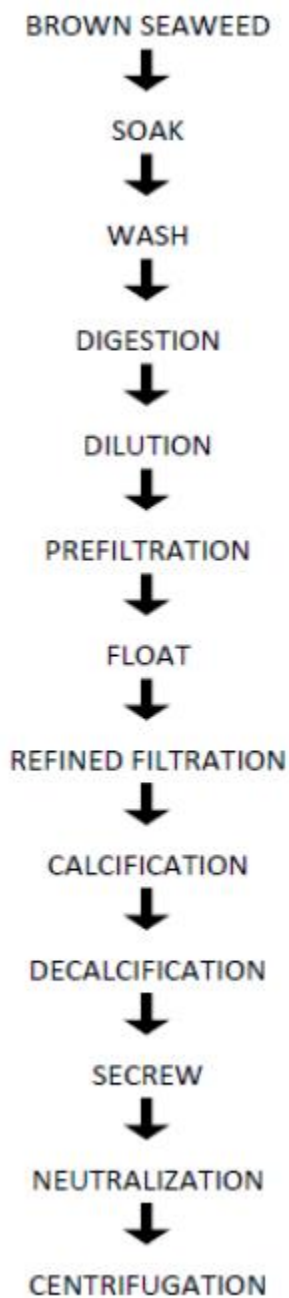

## Manufacturing Process Flowchart Sodium Alginate, NF (Cat# S1118)

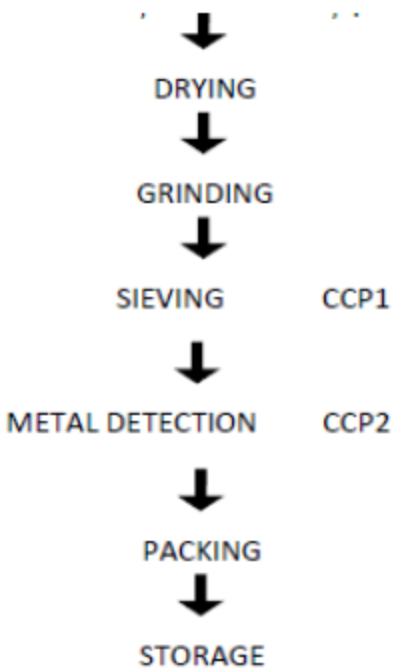

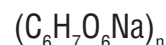
