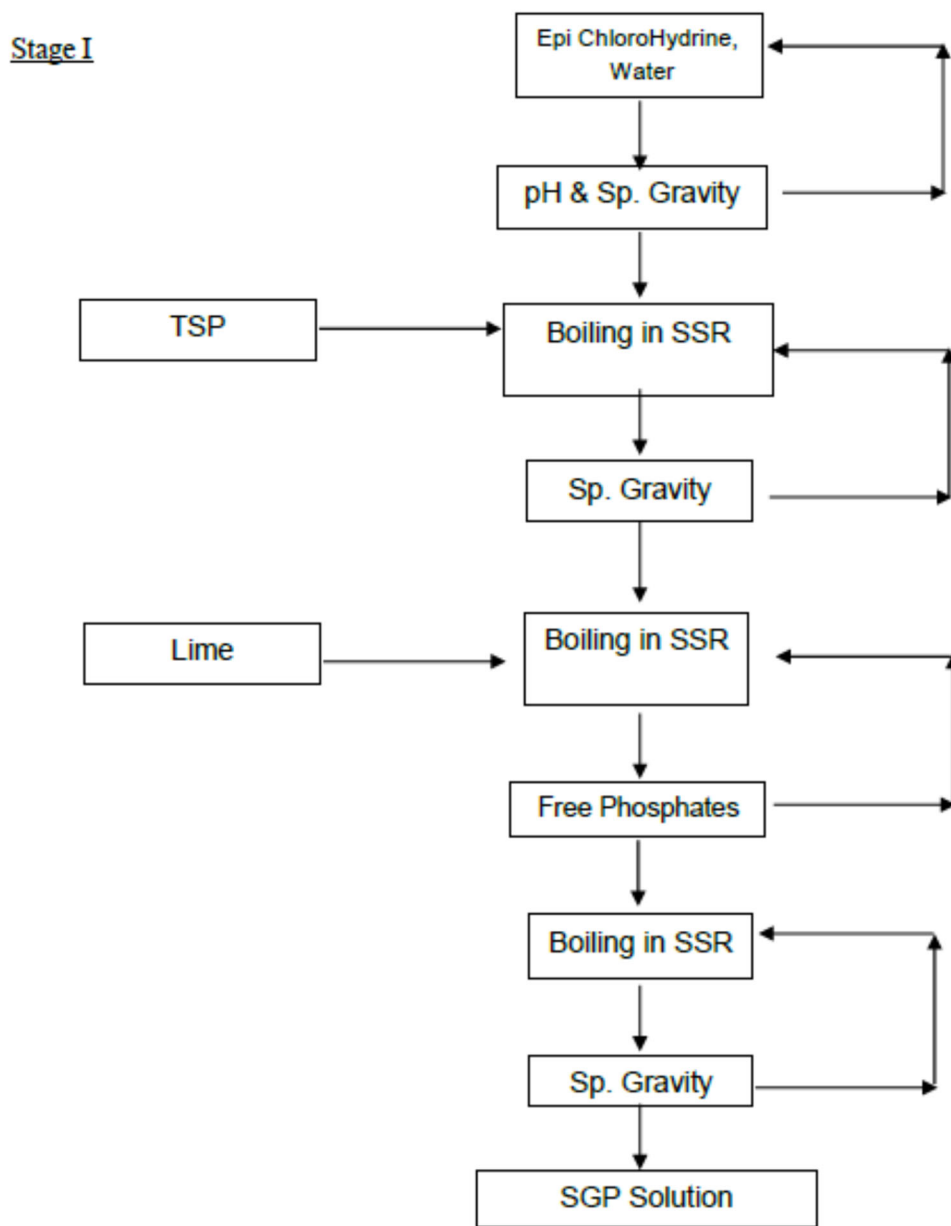

Manufacturing Process Flowchart Calcium Glycerophosphate, FCC (Cat# CA147)



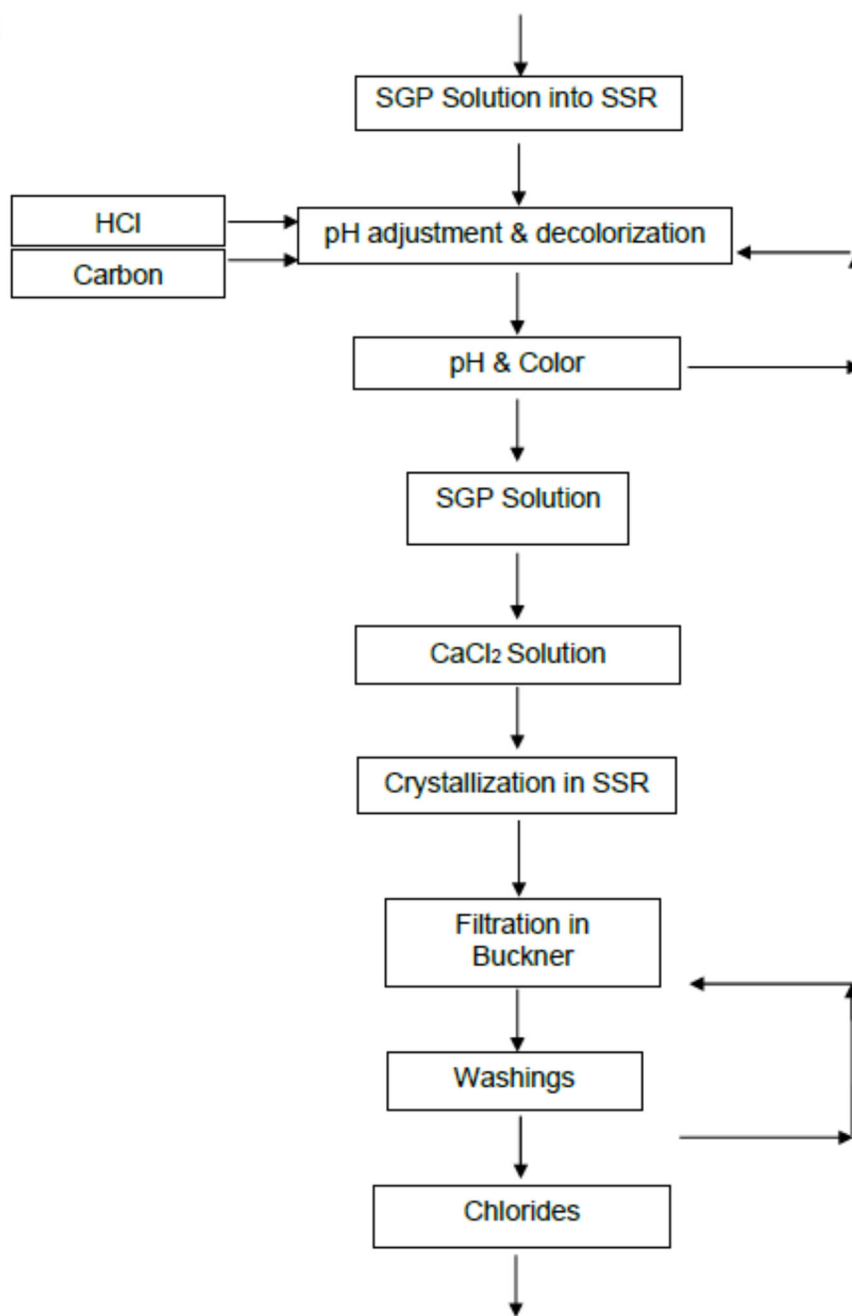

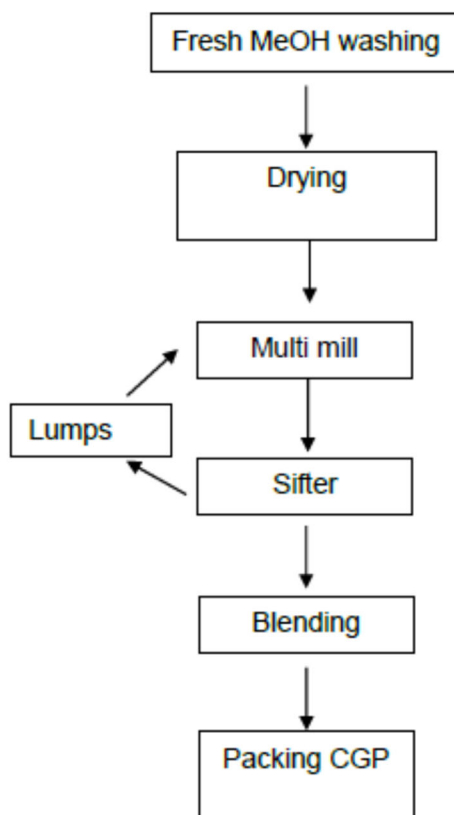
