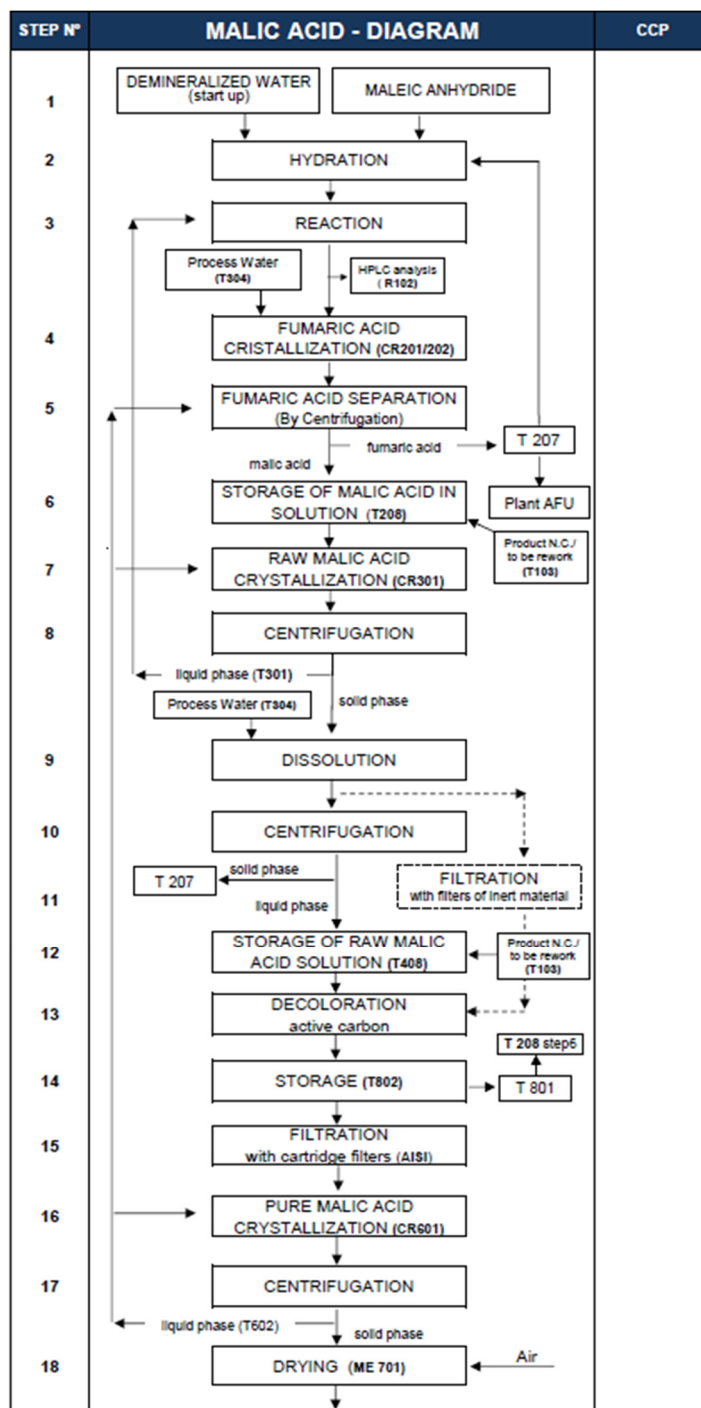

Manufacturing Process Flowchart Malic Acid, FCC (Cat# MA147)

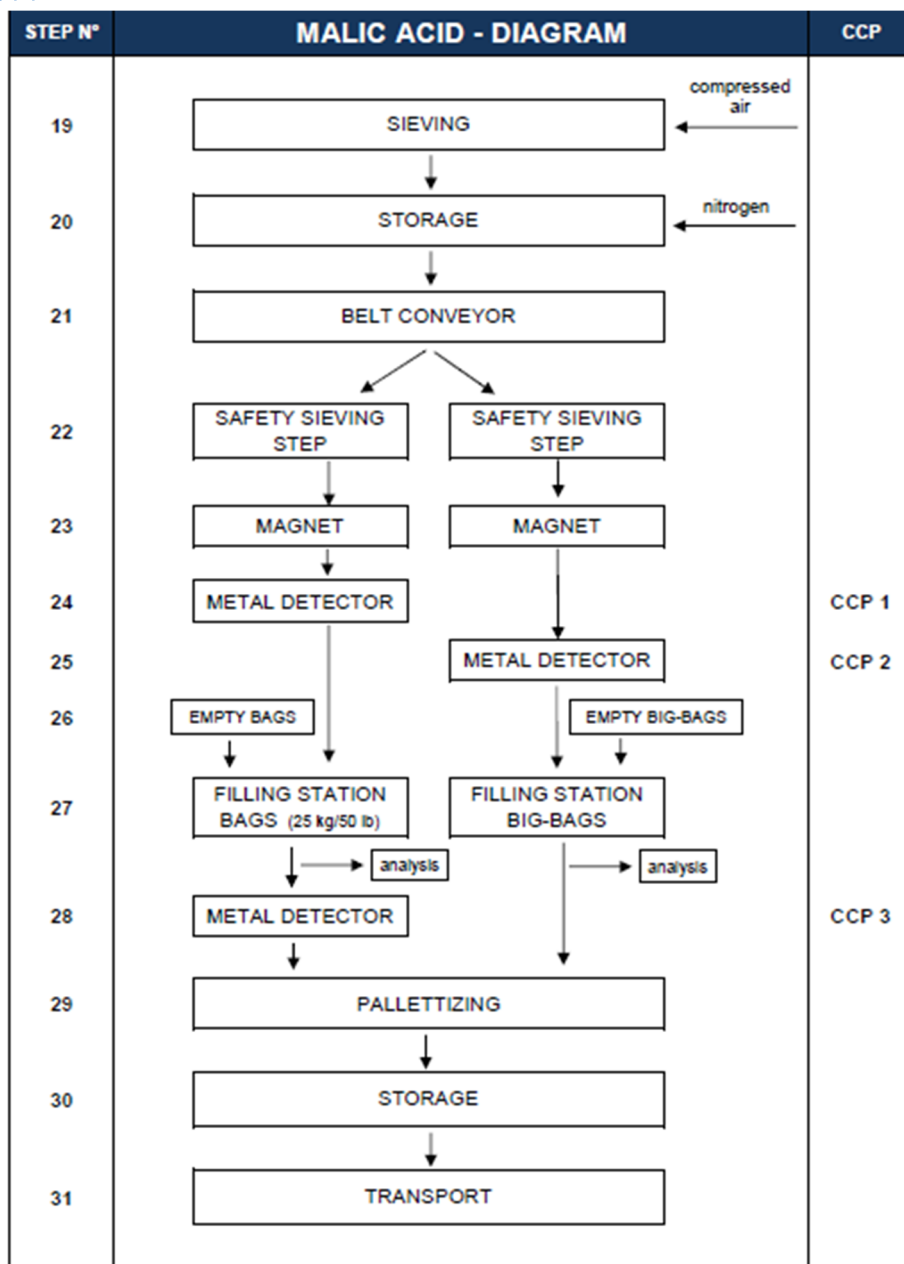
