When primed at high temperature with potassium nitrate-calcium silicide mixture, calcium sulfate mixed with excess red phosphorus will burn. Contact with diazomethane causes an exothermic reaction which may lead to detonation. Many metal oxo-compounds (nitrates, oxides, and particulate sulfates) and sulfides are reduced violently or explosively (undergo a thermite reaction) on heating an intimate mixture with aluminum powder to a suitably high temperature to initiate the reaction. A violent or explosive reaction can occur upon heating when calcium sulfate is mixed with aluminum powder.

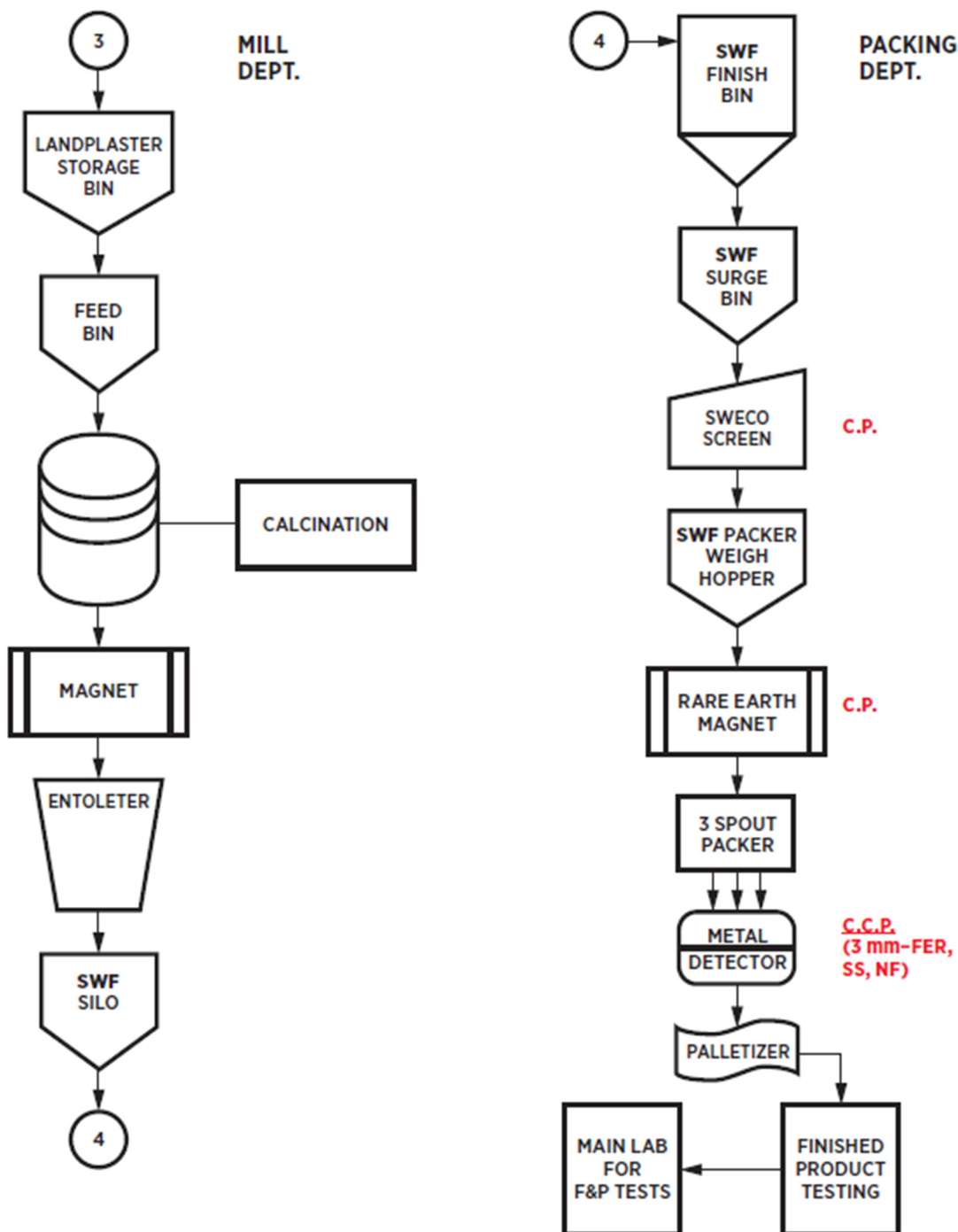
